BEHAVIOR CONTRACT

For the benefit of all, EWO MO has a "3 strikes and you're out" rule. Students will receive clear instructions for expected behavior and any corrective measures. Parents will be informed if their child has received a first and second warning. If a student's inappropriate behavior is seriously disruptive, GIDAS will end his/her participation in the program. If this occurs, no program fees will be refunded. If a child's behavior threatens the safely of any person, the parent/guardian will be contacted and be expected to pick up the child immediately.

LIABILITY AND MEDICAL TREATMENT

I hereby certify that I have read and agreed to the following:

(GIDAS) holds the safety of your child above all else. Our goal is to provide fun, exciting and rewarding learning experiences that are safe and minimize the chances of injury which may be beyond our control and ability to completely protect your child. We therefore require that you understand these risks, authorize us to provide medical care if necessary, and agree not to hold GIDAS or its representatives responsible should your child suffer any injury or illness arising from his or her participation in our program. Please read the statements carefully before signing this document.

I further avow that my release, discharge and agreement shall be applicable to any owner of a facility and/or property at or upon which the program is held. I understand that I am solely responsible for all costs related to any medical treatment, medical transportation, and/or evacuation costs and overnight accommodations associated with the foregoing. I acknowledge that GIDAS will not provide any medical insurance coverage.

I (we) understand that during the participation of my under 18 year old child, he/she may be exposed to a variety of hazards and risks, foreseen and unforeseen, which are inherent in any program, activity or field trip that involves the use of public or private facilities or ocean-related activities (collectively, a "Program"). This program may involve, but is not limited to walking, handling invertebrates, and playing games outside. I further understand that in light of the global COVID-19 pandemic, there is a certain degree of risk associated with the participation of any activities involving other people.
